### **SCOPE OF WORKS:**

The Social Security Board is seeking the services of a suitable and locally based insurance company for the provision of insurance for the Joe's Hill Manor Estate located at Road Town Registration Section, Joe's Hill, Tortola, BVI (hereinafter referred to the 'Estate'). The insurance coverages being sought are Property All Risk, General Third-Party Liability; and Fire and Extended Perils (inclusive of storms and earthquakes), values at 100%. Provisions to endorse the respective homeowners and/or their financing institutions as loss payee(s) as an addendum to the comprehensive policy.

The coverage plan should provide cost for a period of (1) year commencing from 1<sup>st</sup> October 2024 to 31<sup>st</sup> September 2025.

#### **INSTRUCTIONS TO TENDERERS**

Tenderers are required to furnish the following:

- 1) Proof that the company is in good standing with respect to their statutory contributions for Social Security, National Health Insurance, the Commissioner of Inland Revenue and Companies Registry.
- 2) A valid Trade License for the specific type of service detailed in the tender document.
- 3) A valid insurance license pursuant to the Insurance Act 2008 for insurance providers operating in the British Virgin Islands issued by the Financial Services Commission.
- 4) Evidence of Insurance Company rating for minimum credit and claims settlement standard of 'A-'rating.
- 5)Copy of the Register of Directors.

  Preference may be granted to companies that are more than 50% beneficially owned by a citizen or citizens who are bona fide BVIslander(s) and/or BVI Belonger(s).
